Council discussed the matter of the planning application on Silver Street and resolved that the clerk to offer for inclusion on the objection the body of the email sent by Cllr Edwards. It needs to include the following. Outside the development limit of the village. Next to an international wildlife site, locally important landscape area (as per SDC) a viewing point, currently used, will obstruct the entrance. NPPF – if you have a green belt it should eb looked to being opened. Increasing parking and traffic on Silver Street. If unsuccessful at opposing and the development takes placed then a boundary review will need to bring the development into the parish boundaries. If going ahead it must be noted that affordable housing that restricts disabled people due to them not being able to reach the car parking area without using chairs. Properties at top of development have their footway exiting onto Silver Street which is a danger to children and wheelchair users. The drop off is close to the roundabout. Drainage and sewerage, if the roadway on the site is unadopted then the financial obligation for repairs and maintenance to the highway and drainage will fall to the homeowners and tenants. Proposing to

use a wooden boundary fence, not in keeping with the village when other developments had to blend in.
