There has been reports of kids outside Weller House. At the last meeting there was a discussion about restarting the newsletter, can an item be included? It is about indoor bowling. Has there been any progress on a plaque for the bench in the Commemoration Garden?

- i. Chairman: There is graffiti on the back of the skate park shelter
- ii. County Councillor: Nothing offered
- iii. District Councillor: I feel an introduction is in order, my name is Georgina Ashton and I am your new district councillor. I was elected on the 22nd January to represent the district ward. With the unitary changes coming in it means I am a district councillor until the 31st March 2023. As you are aware each district councillor has an annual fund of £3,000 to be used in the communities to which we represent. My allocation was spread between four villages with monies going to the cricket club for a new side screen and to the pop up café. The funds will become available again at the beginning of the new

financial year. It is also worth mentioning that there is the Two Ridings Community Foundation fund available. There are three categories available, up to £2,000, £2,001 to £10,000 and up to £50,000. As part of the unitary changes Fairburn will be part of the Monk Fryston & Sherburn in Elmet constituency. This will include Brotherton and Byram-cum-Sutton as well and be the largest in the new county. As the up-coming elections are for all levels including parish councils all councillors will need to stand for re-election if wanting to carry on. The closing date for nominations is the 5th April. After the elections, contested or not all paperwork MUST be completed by the councillors and returned. This is a legal requirement.

- iv. Other Officers: T Grogan, Cllr Ashton previously mentioned that her monies were spent, she managed to spend the monies in eight days leaving a few pence. The elections mentioned are being held in May 2022. A County Councillor also gets a similar fund available which is set at £10,000 to be spent in their ward. I recently visited the café where a villager asked if Silver Street could be made one way. Would the parish council be interested? Would the village support the idea? A while back there was a fatal accident on to road up toward the village. As there has been comments/grumbles about speeding through the village I would recommend most strongly that the Chairman write to the coroner stating that the accident was due to speed and needs reducing to 30moh as well as extending to outside the roundabouts to the north and south of the village. Fly-tipping, if you spot any contact Alison Beaumont. Gypsies/travellers, ongoing issues which get resolved.
