Poppy light – Residents advised that the light had been damaged in recent winds. The Parish Clerk confirmed that it had been removed for repairs and alterations and will be reinstalled soon.

Traveller's site – Residents requested an update regarding the site as additional vehicles are now present.

Historical signs - Cllr Robinson updated residents that 3 of the replacement signs have been installed, one is with a contractor for repair and he is awaiting a response from the Church before the other can be installed.
