MINUTES

04A/24/01 Welcome & Public participation period

Council to receive comments on agenda items, received from electors.

Residents raised the following matters:

- Rawfield Lane blocked drain the Council confirmed that it has been reported.
- Lamp on Lunnsfield Lane still on the Council confirmed that it has been previously reported. <u>Action</u> – Parish Clerk to chase
- Advertising on Parish Council social media it was confirmed that advertising will no longer be permitted. <u>Action</u> Parish Clerk to action.
- Speed concerns specifically at the top of Caudle Hill and questions on VAS signs including whether additional signs can be purchased the Chairman confirmed that there are currently two signs. The Caudle Hill sign has been turned to face the opposite way. Silver Street sign has been relocated to Rawfield Lane. There is also an additional bracket on the A1246 to allow relocation but it is currently awaiting a power source through NYC. It is recognised that signs become less effective the longer that they remain in one location.
