07/25/01 Welcome & Public participation period

The Council received comments from electors regarding various matters:

- Concerns about out-of-control weeds around the village.
- Notification that Friends of Fairburn School is now funding the Tulip Project.
- Questions in relation to painting the skatepark, approved by the Parish Council last year, which has not yet been carried out.
- Reports of dangerously high vehicle speeds on Silver Street.
- Mixed feedback regarding the Council's agreed plans to replace the dead Christmas tree in the Celebration Garden.
- Streetlights on Lunnsfield Lane reported to be out of order.
- Poor condition of Cut Road <u>Action</u>: The Clerk to send a letter to the previous utilities contractor.
- Ladders left unattended in the ginnel.
- The missing post box.
- Increase in heavy goods vehicle traffic through the village, including during early morning hours.
- Positive feedback received on the recent grass cutting
- Concerns about low water pressure. It was noted that Yorkshire Green may be filling water bowsers locally, which could be contributing to the issue. <u>Action</u>: The Clerk will write to Yorkshire Green to raise concerns.

- The matter regarding the unauthorised traveller site remains under consideration by the Planning Department at North Yorkshire Council.

6.1 To consider the feasibility of modifying the path between the Welltrough and the pump on Cut Road.

Resolved: To install a hardstanding area measuring approximately 1200mm x 1200mm to improve accessibility between the existing footpath and the Welltrough paved area. This will include the construction of a small retaining wall. Councillors will arrange a site meeting to assess the requirements and determine the necessary works.

6.2 To note recent incidents of anti-social behaviour at the Forest School and consider appropriate actions.

A discussion took place about recent incidents of anti-social behaviour within the forest school.

Resolved: Councillors will monitor the area daily for the next week and obtain photographic records. The Parish Clerk will report the incidents to the police.

6.3 To consider actions related to the Light Valley Solar community consultation.

Resolved: The Parish Clerk to share the consultation with residents.

Cllr Edwards will attend the consultation webinar.

6.4 To finalise the proposed list of ACV and listed sites.

Cllr Robinson provided an update on the finalised list and shared a draft of the ACV application form for the Church Hall on Silver Street. An update was also given on the listing status of the village spindle, which has a strong chance of being successfully listed. The application process is complex and conducted online. Cllr Robinson requested feedback on the draft forms.

Following an update, a discussion took place about the research conducted into the status of the Church Hall.

Resolved:

To write to the Parochial Church Council, with copies to the Vicar and Trustees, to address the absence of necessary registrations and to express concerns regarding the vulnerability of this village asset.

 - Land on Silver Street opposite the recreation field.

6.5 To consider options for continuing village flower planting, building on previous community efforts and taking into account the allocated budget.

Resolved: To return the budgeted funds to the general reserve.

6.6 To consider outstanding village maintenance issues and quotations received.

The Council noted that the wall on North Road requires additional repairs. Quotes for tree cutting along the A1246 were not available at the time of the meeting.

Resolved: To approve costs of £450 for paint and signage at the skatepark.

6.7 To consider any necessary actions in relation to the Community Centre meeting (subject to response).

Resolved: To share the NALC information with the Community Centre and offer a meeting on 24th June 2025. To request an up-to-date copy of the licence to occupy before the meeting. Cllrs Edwards and Robinson will attend the meeting along with Cllr Kos is three attendees are required.
